Guidelines for the Preparation of Master's Thesis

- ① Finding a thesis advisor
- ② Applying for Mid-term Thesis Review (Proposal)
- ③ Applying for Oral Defense
- ④ Revising thesis
- ⑤ Thesis uploading/submission
- ⑥ Graduation

FINDING THESIS ADVISOR

1. For **double/ triple degree** students, please find your co-thesis advisor before the **2nd week** of 1st semester.
2. For **regular students**, please try to find your thesis advisor **at the end of 2nd semester**.
3. You need to cooperate with your advisor at least for **6 months** before you apply for the oral defense.
4. You need to submit the **application form** when you decide your thesis advisor.

Mid-term Thesis Review

- Finding panel members for proposal.
- Submit application to program office at least **3 weeks** before the proposal.

Oral Defense

- Submit application to program office at least **1 month** before the defense.
- Provide thesis in PDF file to program office **2 weeks** before the defense for the plagiarism test.
- Please follow your advisor's regulation for the preparation.
(ex. Sending invitation letters/ thesis hard or soft copies to panel members...)
- Submit transcript, the certificate of proofreading and the certificate of academic research ethic course before the oral defense.

★ **Overdue application will not be accepted**

Revising and Uploading Thesis

- After finish revising thesis based on panel members' suggestions, please let your advisor make final confirmation.
- After getting approval from advisor, program office will provide the approval letter for you to upload the thesis.
- Please follow the instruction to upload thesis via library online system.
- **Please notice the deadline of thesis uploading, library will need 3-5 working days to review your uploading. If you need to leave school or Taiwan in particular dates, please set up the schedule!**

School leaving process & Graduation

- After uploading thesis, you will get an approval email from library.
- Please inform program office the date you're going to take your diploma and also do the school leaving process on the same day. (School will need **5 working days** to prepare your diploma)
- Before you take your diploma, please go to [e-campus service](#) and print out the form of "Graduate's leaving school procedure".
- Please take the form to program office to start your school leaving process.
- You'll get your diploma at the end of the process, congratulations!


